1. At least one rendering of the proposed bath (for *Unbuilt* entries) or one image of the completed bath (for *Built* entries)
2. At least one floor plan of the project
3. At least one “before” photo of the bathroom (*N/A if it is a new build*)

#### **Unbuilt (Designer’s Own Bath) Rules:**

Entries will be accepted only from designers within the Frank Webb Home region: Connecticut, Maine, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont. Submissions must include products from at least one of the following collections: Happy D.2 Plus, Viu, XViU, and SensoWash® i. Duravit is not responsible for installation of prize materials. Winner must accept product when it is ready to ship; Winner must obtain all products by January 31st, 2020 or forfeit prize entirely. Winner must also work with Duravit to obtain photography of completed project by January 31, 2021 for Duravit's promotional use. One winner will be awarded the Duravit items used in his or her project up to a value of \$10,000 and professional photography of the completed project.

#### **Built Rules:**

Submissions in the “built project” category must include Duravit. By way of their submission, the designer agrees that their project has been completed between October 2014 through October 2019. Renderings in the Built category will not be accepted.

Entries will be accepted only from projects within the Frank Webb Home region: Connecticut, Maine, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont. Eligible to receive up to \$5,000 in product value.
